# GENERAL RULES AND CONDITIONS

*Please read this information carefully.*

## **Cross-Institutional Students**

Students enrolled in a program of study at one higher education institution who want to count courses offered at one (or more) other universities as part of their award may be admitted to such courses as cross-institutional students.

## **Home Institution**

The university at which the award will be conferred is referred to as the home institution. For advice on submitting your application for enrolment as a cross-institutional student, consult your Faculty/School administrator at the home institution.

## **Host University**

The University of Adelaide is the "host" university at which cross enrolment in courses is sought. You will need to obtain permission from your home institution before lodging this form with the University of Adelaide.

## **Quotas**

Normal quotas that form part of selection processes to award programs do not apply. However, the University of Adelaide may not admit cross-institutional students in cases where insufficient places are available for its own students.

## **Conditions of Admission**

Cross-institutional students are subject to the same Statutes, Regulations, Rules and Policies as apply to students enrolled in an award course at the University of Adelaide. These Statutes, Regulations, Rules and Policies relate to attendance at classes, performance or work, discipline, conduct and progress and are to be found in the University's publications.

If a cross-institutional student is subsequently admitted to a program leading to an award at the University of Adelaide courses passed while enrolled on a cross-institutional basis may only be counted towards an award if specifically approved by the relevant Faculty or School.

## **Invoices and Commonwealth Assistance Notices**

All invoices and Commonwealth Assistance Notices are generated electronically through Access Adelaide. Emails are sent to University of Adelaide student email accounts advising when an invoice/notice is available.

## **Fee Status**

- If you are a Commonwealth Supported student you must complete a Request for Commonwealth Support and HECS-HELP form. This includes students who are New Zealand Citizens and Permanent Residents who are eligible to enrol as Commonwealth Supported students. . Forms are available from the Student Centre. Before completing this form you must read the information for Commonwealth Supported Students booklet, available from <http://www.goingtouni.gov.au> (hardcopy is available from the Student Centre) to understand your obligations.
- Domestic fee paying students may be eligible to apply for FEE-HELP assistance by completing the Request for FEE-HELP Assistance form. FEE-HELP is a scheme that operates in a similar way to HECS-HELP in that eligible students can borrow from the Commonwealth government for some or all of their tuition fees (within set limits) and repay this through the taxation system. Forms are available from the Student Centre. - International students will be liable for international tuition fees.

## **Withdrawal**

If you wish to withdraw from your cross institutional course you must officially withdraw on the Course Drop form of the University of Adelaide. If you do not wish to consume Student Learning Entitlement (SLE) or incur a Student Contribution/tuition charge, the Course Drop form must be lodged before the census date, 31 March (Semester 1) or 31 August (Semester 2). Information on census dates for courses in other teaching sessions, as well as Withdraw No Fail dates and other critical dates is available at [www.adelaide.edu.au/student/dates/](http://www.adelaide.edu.au/student/dates/) Withdrawals lodged after these dates may be permitted but you will consume SLE and incur a Student Contribution Charge

## **TO LODGE THIS FORM:**

1. Choose the course(s) you wish to study at the University of Adelaide and enter the details in Section 2.
2. Obtain authorisation from your home institution by having the form signed by an authorised person from your home institution.
3. Obtain authorisation from the University of Adelaide by having the form signed by the appropriate authorised person or persons from the University.
4. Make sure you complete all sections of the form and take a copy of the signed form for your personal records.
5. Present the completed and signed form to the relevant Faculty/School Office at the University of Adelaide as your authority to enrol together with your completed Request for Commonwealth Support and HECS-HELP or Request for FEE-HELP Assistance form. Consult the relevant Faculty/School Administrator to determine enrolment dates and procedures.
6. It is your responsibility to relay results to your home institution to confirm your credit/status for those course(s). Your home institution, however, has the authority to request these results from the University of Adelaide.
