1 Welcome and Apologies

Apologies were noted as above.

The Convenor welcomed Bryan Woochan Lee who is now representing Ask Adelaide.

2 Confirmation of Minutes

Minutes of the meeting held on 20 August 2019 were accepted. There were no actions.

3 Safety Performance of the Division

The committee noted the report.

Paul highlighted that DASE's level of reporting is very good and more hazards are being reported rather than just injuries. Walking around the campus is still the most hazardous thing that staff can do.

Overdue actions have now been closed.

DASE do not have many workers compensation claims.

The Hazard Management chapter of the HSW Handbook is currently out for consultation.

Work on a consolidated Divisional SPE and Hazard listing are being developed. The Committee should check the templates and provide any feedback to Paul.

A handbook chapter is being developed for joint research collaborations with other organisations so that incidents can be reported.

Traffic light report is currently green.

The terms of reference have been approved by governance but for next year but the membership should be reviewed.

Action: Dave and Rosemary to check the membership and make sure all areas are covered.

Committee members to check the First aid list and if staff are missing encourage them to go into SSO and upload their first aid certificate. The report will be available for each quarterly meeting.

4 Effectiveness of safety processes in the Division.

Angela asked about inductions for staff who have moved around the university and if they should be included on the training plans as it is not clear when they were originally inducted. Paul advised that they should be inducted into the local area each time they move but whilst there is a requirement to ddeliver the information in regards to floor wardens, first aid officers or how to report a safety issue there is no requirement to record the induction has taken place or the date it took place.

5 Are there any safety concerns that staff representatives want to raise?

There were no concerns raised.

6 Key changes to Divisional safety processes that need noting or discussion?

Paul reported that this will be the last year that each area finalises their final SPE and training plans as staff should be uploading their warden training and first aid training to SSO. The new consolidated Divisional SPE will be available for the first meeting next year for the committee to check.

The mandatory evacuation drills will also be included on the SPE.

7 Is there anything that we need to communicate to the wider division?

Committee members should go back to their areas and advise on the new consolidated SPE.

8 Any Other Business

If staff think something is a safety issue that could cause injury and harm then they should report it on UniSafe. For things like poor lighting, broken bulbs, bad paving then staff should take a photo and report it.

The RCC will be on campus again next year, Mike Brewer is the contact to report any hazards or problems that might arise from them being on campus.

Dave thanked everyone for their attendance and help throughout the year.


This report is prepared by the Senior HSW Advisor for the Divisional HSW Committee based on the data within UniSafe, HSW Internal Audit outcomes and workers compensation data. The intention of the report is to enable discussion by the Divisional HSW Committee of the safety outcomes for the Division.

1. UniSafe Safety Reporting Data

By the end of 2019 there were 1118 incident reports recorded in UniSafe. As can be seen in Table 1 the majority of these are recorded in the Faculty of Sciences and the Division of University Operations. When broken down into School/Branch there were two clear areas where safety issues were reported

- Infrastructure 30% of all Incidents reported
- School of Animal and Veterinary Sciences 18% of all incidents reported

The Injury rate for the University at the end of 2019 was still very high -41% of all safety incidents reported were injuries. However, it continued the positive trend of a declining injury rate for the last two years. Incident reports should never be seen as a negative indicator. The more disciplined staff, students and contractors can be at reporting hazards they notice in the workplace the more likely we are to decrease our injury rate.



It is important to remember that, in accordance with the University HSW Handbook Chapter – Report a safety issue or incident, Staff, students, contractors and visitors are required to report anything they think is a safety issue. A safety issue is

- Something that unless action is taken, may cause injury/illness; or
- An event that occurred that did, or could have, caused injury or illness.



2. UniSafe Overdue Corrective Actions Data

There are currently no overdue in UniSafe for DASE.

3. Workers Compensation Data

The total number of workers compensations claims to the end of 2019 was 33 compared with 38 for 2018. Of these, 45% of claims were in the Faculty of Sciences and 18% were in Controlled Entities such as National Wine Centre and Adelaide Unicare.



4. HSW Internal Audit Outcomes

Q4 Audits were primarily conducted on Schedule of Programmable Events

No areas in DASE were a part of Q4 Audits.

5. HSW Handbook chapters revised in the last quarter

The following table is provided to allow discussion on impending consultation or implementation issues resulting from new procedures or advice.

New/Revised Handbook Chapter/FAQ's	The key changes to the chapter for noting are -
Hazard Management	There is no longer a requirement to maintain a Hazard Listing. The requirement to maintain a Hazard listing is not a legislative requirement. The original intent was to have a listing to assist with the induction of staff and to have a reference point to access completed Risk Assessments. In lieu of maintaining a Hazard Listing, the Supervisor/Person in control of the area/activity now needs to ensure that they have a system in place, for retaining formal Risk Assessments for the duration of the
	activity and to ensure that workers know they exist and where to access them (e.g. this could be a folder in a lab or workshop, or on the intranet).
	There is a new 5 step Hazard Management process (Appendix A) to replace the existing Risk Assessment Decision tool This 5 step process summarises each of the stages of the Hazard Management process from start to finish and how to determine if a formal Risk Assessment is required or not. It includes a number of examples of hazards and how/when a worker could be exposed to the hazard. It also provides some examples for some specific activities. This Appendix could also be used by a Supervisor or HSW Officer when explaining to another staff member or student how to complete a Risk Assessment.
	There are 3 new Risk Assessment templates which should fit all circumstances (1) Appendix B1 – Single Task – Might be used for an activity that is completed over and over again in the same way (2) Appendix B2 - Multiple Tasks – Provides the option to include a number of different tasks for one location and/or to use control banding e.g. Standard Precautions for infection control This enables areas to implement what it currently being used as an Overarching Risk Assessment but reinforces that hazards and controls must be clearly defined and align to the hazard (3) Dynamic Risk Assessment – For a simple task. The format of the template provides a quick "tick and flick" option to save time. The same levels of authorisation apply.
	Note: There is no requirement to re-write any existing Risk Assessments unless the existing Risk Assessment does not meet the requirements of the revised chapter e.g. if the control measures do not address the hazards identified. This exclusion also applies to any existing Overarching Risk Assessments. If they are accurate and compliant then they may still be used.
	There is a requirement for the Supervisor/Person in control of the area/activity to authorise all risk assessments before the activity is completed, regardless of the level of residual risk. This change will ensure that Supervisors are aware of the all the activities in their area of control. Noting that the Supervisor/Person in control of the area/activity may sign off on their own Risk Assessment.
HSW Collaboration with	This chapter will provide a process and template for:
other organisations	facilitating a discussion between the parties involved at the
(including Co-location)	commencement of a collaborative project;

	 identifying the key elements of safety; and agreeing on which organisation has the responsibility to ensure the HSW legal requirements are met. (e.g. is it one organisation or the other or is it a shared responsibility?) The template includes activities such as: hazard management; provision of information, instruction, training and supervision; workplace monitoring/inspections; maintenance and use of plant/equipment; management of hazardous chemicals (including radiation); personal protective equipment; reporting of safety issues and incidents; and emergency management. Please note: There is a requirement for the retention of HSW Collaboration agreements in accordance with the State Records Act. The Supervisor/Person in control of the area/activity needs to ensure that they have a system in place for retaining the agreement. This is a requirement under the State Records Act Schedule 30. The agreement may be stored locally until placed into the University's archiving system. The University's Records Management Office can be contacted for further assistance/information if required.

6. Draft DASE Traffic Light Report (Q1 2020)

Where actions are decided to address breaches of a HSW handbook chapter - and are completed - the traffic light report will be flagged as Green A. However, no recorded actions or outstanding actions will be recorded as Amber or Red depending on the due date of the action. This does not include Safety Reviews undertaken by the HSWO's. Therefore, it is important that the traffic light report is discussed within the Divisional safety committee meeting, to ensure that it is correct.
