3 Safety Performance of the Division

The report was noted by the Committee

Paul reported that there were the same issues being identified and reported. One unusual incident reported was someone fainting at a smoking ceremony. Incidents in our division still lean towards manual handling, body movement, slips, trips and falls. Reliance is on university staff to report any hazards noted on campus. Send a request for maintenance via their webform or an incident via Unisafe.

There is no specific site within the Division that has been chosen for the return to work audit. The audit will be focused at the Roseworthy campus.

The traffic light is currently green.

A spreadsheet has been circulated which is broken down into the different units and any training required is highlighted in red. If a role has changed, ie first aider or firewarden, the staff concerned should go into SSO and remove their credentials. Any questions please contact Paul.

Dave advised that it is up to Managers to make sure there are staff in the first aid and fire warden roles, it is not up to committee members, if there are any problems please contact him and he will follow up.

4 Effectiveness of safety processes in the Division.

Paul confirmed that this agenda item is to discuss how well any incident reports are followed up, induction in areas and monitoring of Health and safety issues.

5 Are there any safety concerns that staff representatives want to raise?

Paul reported that electrical testing, which was carried out some years ago but was terminated due to changes in the law, has now been reinstated by the Federal Government. This means that all areas will need to have any electrical items (that plug into a wall) that are owned by the University tested and tagged by a competent person.

Finance and Procurement are close to selecting a preferred provider for that service. A new handbook chapter has been written with a time line of being compliant by the 31 December of this year. Areas should plan for their testing and tagging now.

A register will be produced at the first check, of all the items tested and where they are located which will give a baseline point for when they are tested again in 5 years. Current computers have been tested so won't need to be tested for another 5 years under the current legislation. If they are leased they may not have to be tested again. Kitchen items and any other items not previously tested will need to be tested.

The start of this testing is quite easy but maintaining it can be challenging due to disposing of equipment or moving locations as the obligation will be on us to find that item and have it tested again. In the past finding items or having access to rooms which may be locked were some of the minor issues. There will not be dedicated resource for this it will be a branch responsibility as an administrative task, it doesn't require specialist knowledge. It could be assigned to one staff member to oversee or more than one.

Any questions re the process or what is required please contact Paul.

It is important that this information is taken back to your managers and discussed how it will be carried out.

Dave asked if the computer is new and under lease it doesn't need to be tested? Paul advised that they are working with ITDS to re-establish the process where anything new coming in is already tested and tagged, if currently not tested and tagged then they will need to be tested.

Personal items such as mobile phones if plugged into the wall to be charged will need to be tested and tagged. If they are being recharged by a usb they don't need to be tested.

Simona asked if devices that are used at home for working from home are required to be tested and tagged as well? Paul advised not if they are personal computers. If they are university supplied and brought in to the University and plugged in at any time then yes, they should be tested. If people are continuing to work at home but using University equipment then they should be requested to bring the items in at the time testing has been arranged so that those items can be included.

If people refuse to have an item tested and tagged and then they bring that item in and want to use it on campus the University has the authority to request they do not plug it in until it has been tested and tagged.

Fred asked about efficiency around the testing, for example in RMP it would best to do every area all at once, not have technicians coming in at different times. It was agreed that leadership in RMP should discuss and arrange to have the testing done all at the one time.

It was confirmed that each local area is responsible for the payment of having the testing and tagging carried out. It is expected the highest cost will be the start of this first round and then should be smaller the next time around.

If an item fails the test the provider will immediately make it safe, tag appropriately and notify the area of the failure. The handbook chapter outlines the action to take if an item fails.

If an item is deemed valuable enough then it could be repaired otherwise disposed of and if necessary replaced.

Small heaters require annual testing as they have a high failure rate.

Bryan asked if the equipment that students bring in and plug in to the University electricity supply in the Hub are included? Paul advised that student equipment is not required to be tested. Infrastructure is responsible for the charging banks in the Hub and they have appropriate RCD protection so that if a faulty item is plugged in and has some leakage the RCD will trigger protecting both the electricity supply and the person plugging it in.

Action: discuss with management the requirement to have testing and tagging done once the new provider has been selected.

Action: check the handbook chapter for details on how often items need to be tested and tagged.

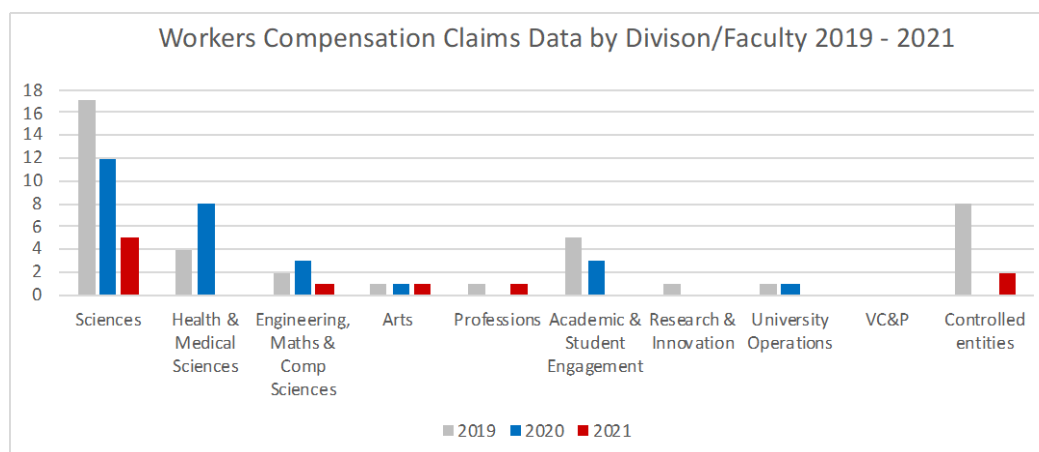
There will be a number of observations and notes that will form opportunities for improvement for the University over the next 5 years. It will take some weeks to get a formal result with its subsequent details.

6. Draft DASE Traffic Light Report (Q2 2021)

The traffic light report (attached) is based on the information recorded by the incident investigator in UniSafe and the findings from HSW internal audits. Where actions are decided to address breaches of a HSW handbook chapter - and are completed - the traffic light report will be flagged as Green A. However, no recorded actions or outstanding actions will be recorded as Amber or Red depending on the due date of the action. This does not include Safety Reviews undertaken by the HSWO's. Therefore, it is important that the traffic light report is discussed within the Divisional safety committee meeting, to ensure that it is correct.

Information Sheet

Electrical Testing and Tagging using eSafe
Version 1.0 dated 13/07/2021



This information sheet will help guide local areas in their preparation for electrical testing and tagging using eSafe and will ensure a quick and easy process to request testing and tagging be performed in your area. Specific roles and responsibilities are set in the [Electrical Safety Management](#) handbook chapter.

What needs to be tested

Electrical equipment, owned by the university, needs to be regularly inspected and tested where it is:

- ☐ Supplied through a general power outlet (GPO) or
- ☐ Used in an environment in which normal use of electrical equipment exposes the equipment to operating conditions that are likely to result in damage to the equipment or reduce its lifespan (moisture, heat, vibration, dust) or
- ☐ A Residual Current Device (RCD).

Electrical equipment owned by the University that is used in the home will still need to be tested and tagged. However, where the device is connected with a power cord using an AC/DC adapter, thereby ensuring the device is not powered by 240V, only the power cord and adapter need to be tested and tagged. See examples here:



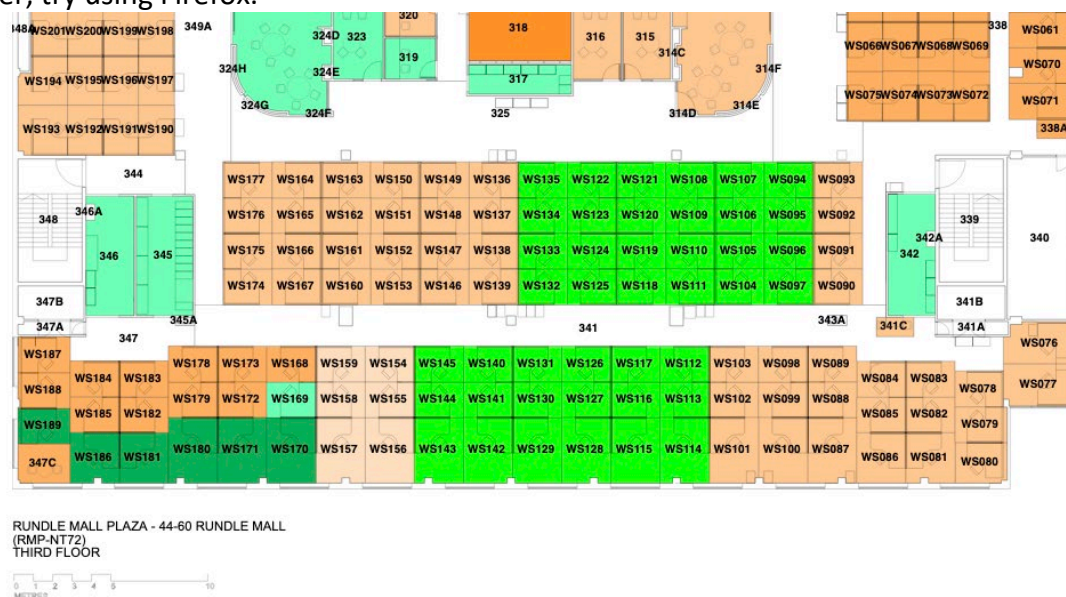
Where a power cord is plugged directly from the GPO to the device, without an AC/DC adapter, the cord and device must be tested together. See example here:



Note: Leased/hired equipment should be provided by the supplier with testing and tagging tags already attached.

Step 1 – Mapping your Area

The simplest way for areas to do this is to use [UniSpace](#). This website will allow you access to up-to-date floor plans with the ability to add room numbers and colour coding to identify rooms and workstations that need to be entered and tested by technicians. The default colours of departments can be changed, and we suggest you use Fluro Green to mark your area. If you have any trouble using UniSafe with your usual browser, try using Firefox.



Step 2 – Assign a local coordinator and request testing and tagging

The area should appoint a contact person who will act as the local person to liaise with and report to on the date of testing. It will be the responsibility of this person to ensure:

- staff on the floor are aware that testing is occurring,
- that staff with university supplied electrical equipment for home offices are advised what needs to be brought in for testing and tagging,
- what is required on the day of testing (i.e. powering down of their devices for the technician),
- that the technician will have access to all of the rooms.

Note: on average, one technician can test between 200 and 300 items per day. The technician will need access to each workstation for between 5-10 minutes. Computers must be shut down and turned off.

FINAL STEP – recording actions taken on failed items

A description of the actions taken on failed items (if any) needs to be recorded. These can be simply noted on the eSafe report (either by hand and then scanned or electronically). Remember the usual choices in these instances are to have the items repaired or organise their disposal. The local contact should then report these as a safety issue in UniSafe and upload the appropriate information to record this in the HSW system. It is advised these be reported as follows:

UniSafe notification question	Suggestion or guidance on what to report
What happened?	Write “Electrical testing and tagging by eSafe identified failed items that were tagged out”
Where did it happen?	List the area (School/Branch) where failed items were identified.
Photo’s	Upload a copy of the eSafe report identifying the failed items and the action noted/taken.
Which area do you think needs to respond to this report?	If your area is not in a Faculty or Infrastructure, then choose “other”.
Describe the actions taken immediately after the incident occurred?	Write “Failed items tagged out and actions noted in uploaded reports”.
