JMC Activities and Results, 1 September 2019 - 31 August 2020

The third year of the Jean Monnet Chair (JMC) project was concerned with teaching EU-related courses at the University of Adelaide and mini-courses elsewhere, contacts with other EU centres in Australia and with academics in Europe, and outreach to a wider audience. As Director of the Jean Monnet Centre of Excellence, the JMC was also heavily involved in the Adelaide-Bologna Dialog on EU-Australia Relations and on running seminars and a Discussion Paper series on international trade.

From 29 February to 18 March 2020 the JMC was in Europe intending to arrange the Study Tour for October 2020 and the 3rd. Adelaide-Bologna Dialog on EU-Australia Relations. While in Europe visiting Brussels or Bologna proved impractical due to COVID-19. After returning to Australia he was required to self-isolate and was unable to leave Adelaide for the remainder of the JMC project, which substantially constrained outreach activities.

For the third year, the full-semester course ECON3526 on the economics of European integration was taught to senior undergraduates and to postgraduate students at the University of Adelaide. The course involves 39 contact hours (three hours per week in a 13-week semester) plus examinations and grading of assignments and papers. The enrolment of 25 students was the highest so far, and once again the student evaluations were strongly positive

The course ECON 3527 on EU-Australia economic relations was taught in the second semester (July-November 2019) and included a two-week study tour to Paris and Brussels at the end of the semester.

Unfortunately, the EU-Australia economic relations course ECON 3527 scheduled to be taught in the July-November semester 2020 with a study tour to Europe had to be cancelled due to restrictions on travel out of Australia. Many other planned activities after March 2020 were either cancelled or postponed (and the eventual events were online).

At the University of Adelaide, the JMC contributed a guest lecture on the EU and Australia to a large first-year course ECON1002 Australia in the World Economy. The JMC also gave presentations to student groups and public lectures to wider audiences. The JMC collaborated in coordinating and hosting the seminar series of the Institute in International Trade (e.g. seminars by Andreas Freytag, University of Jena, on 26 September 2019 and by Hein Roelfsema, Utrecht University, on 17 February 2020) and managed the Discussion Paper series of the Jean Monnet Centre. Outside the university, he gave guest lectures on EU-related topics and participated in round tables and other events in South Australia.

A major initiative of the JM Centre of Excellence has been the Adelaide-Bologna Australia-Europe Economic Relations Dialogue. The first Dialogue, held in Bologna on 1st. October 2018, was a round table discussion under Chatham House rules, with a Keynote public lecture by former Commission head Romano Prodi. The second Dialogue, held in Adelaide on 13 September 2019, featured discussion around four papers that were published as Policy Forum in the December 2019 issue of the Australian Economic Review. The JMC led the organization of the Dialog, in conjunction with JM Project Coordinator Sarah Warner, and edited the Policy Forum.

The JMC maintained close relations with the EU Delegation in Canberra and with other Jean Monnet Centres. On Europe Day, 9 May he attended the EU reception Canberra.
