# Application for Change of Attendance Status

## Division of Research and Innovation

- This form applies if changing from Full-time to Half-time or from Half-time to Full-time.
- A research student may apply to change attendance status from half-time to full-time or vice versa throughout the duration of candidature Scholarship holders are normally full-time only.
- The change must be endorsed by the student's principal supervisor or Postgraduate Coordinator.
- A change in attendance status will affect your RTP expiry date. If in doubt, please contact the <u>Adelaide Graduate</u> <u>Research School</u> for clarification.
- International students who are in Australia on a student visa are normally required to maintain a full-time enrolment.

  Please check with International Student Support regarding how your visa may be affected before submitting this form.

#### **Scholarship Holders**

- Under normal circumstances, students in receipt of a scholarship and are required to maintain a full-time enrolment.
- If you are in receipt of a scholarship funded by an external organisation, please check whether the conditions of your scholarship permit half-time study.
- Half-time awards are not considered to be exempt from taxation. However, they may fall under the taxation threshold, depending on the individual situation of the recipient.
- Half-time awards are only approved where an applicant is able to demonstrate heavy carer commitments or a medical condition that prevents them from undertaking full-time study. The follow supporting documentation is required:
  - o For conversion to a half-time attendance status: a Tax File Number Declaration form
  - o For caring responsibilities: birth certificates of children
  - o For medical reasons: medical certificate(s) from the relevant medical practitioner(s)
- Half-time awards are not available to applicants seeking to undertake paid employment.
- If you do not have a Tax File Number you will need to apply for one. The Australian Tax office website provides instructions for applying if you are <u>currently in Australia</u> or if you are <u>currently outside Australia</u>.
