Confined Space/ Register

Definition

A 'confined space' means an enclosed or partially enclosed space that:

- is not designed or intended to be occupied by a person
- is, or is designed or intended to be, at normal atmospheric pressure while any person is in the space; and
- is or is likely to be a risk to health and safety from:
 - an atmosphere that does not have a safe oxygen level, or
 - contaminants, including airborne gases, vapours and dusts, that may cause injury from fire or explosion, or
 - harmful concentrations of any airborne contaminants, or engulfment

This Confined Space register provides information on:

- Location of confined space
- Photo identification

Note: This is not a risk assessment. Persons accessing the Confined Space must conduct a risk assessment and SWMS/JSA relevant to the task they are undertaking prior to entering the confined space.

Work permit with SWMS required for entry into confined space

Where pits need to be emptied University of Adelaide strongly recommends the use of the vacuum system.

This Register excludes 3rd party asset owners pits e.g. SA Water, SAPN and Telstra
