

## UTR1.82 - MOOTING PRIZE FOR THE BEST MOOT TEAM

- A. Originally, an amount of \$50 was provided to the University of Adelaide in 1972 by The South Australian Barr Association for a prize for a competition in Moots.
- B. The University accepted the bequest upon the trusts specified by the donor and the bequest therefore became the capital subject to those trusts ('capital sum').

### Name of the fund

1. The capital sum, all income arising from the capital sum and any accumulations and additions thereto together form a fund called the 'Mooting Prize for the Best Moot Team' ('fund').

### Investment of the fund

2. The fund is to be amalgamated for the purposes of investment, and held in a common fund, and the net income earned by the common fund shall be credited, rateably, to the funds so amalgamated and thereafter distributed according to the bequest of the donor.

### Obligations

3. In administering the fund, the University must adhere to the terms specified and is obliged:-
  - (a) to invest the capital sum according to the directions of the donor(s); and
  - (b) to establish a prize to be administered in accordance with the following Rules.

### Rules

#### Title

1. The prize shall be known as the 'Mooting Prize for the Best Moot Team'.

#### Value

2. The value of the Prize shall be \$2,400 or such other amount as the University shall from time to time determine provided that the value of the prize does not exceed the annual distribution of income available from the Endowment Fund.

### Eligibility

3. To be eligible for the prize candidates must have participated in mooting competitions organised by the Adelaide Law School in the year for which the Prize is awarded.
4. Candidates are ineligible if they:-
  - have provided false or misleading information that has a relationship to the awarding of this Prize;
  - have been found guilty of misconduct by the Student Misconduct Tribunal and have had relevant penalties imposed on them in accordance with the University's Policies, Rules and Statutes for Student Misconduct.

## Selection of Candidate

5. The mooting coordinators of the Adelaide Law School shall provide nominations each year to the Dean, Adelaide Law School for consideration. The Prize shall be awarded annually to the best mooting team as determined by the Dean and a sub-committee nominated by the Dean.
6. If the Prize is not awarded in any year, then the available income distribution shall be added to the capital sum in the Endowment Fund.
7. If there is more than one candidate of equal merit, preference may be given to the candidate who is deemed the most outstanding candidate taking into consideration aptitude, enthusiasm and participation as determined by the School.

## Administration and Variations

8. The value of the prize shall be split equally between the members of the winning team.
9. The Prize will be administered by the Coursework Scholarships and Prizes Office.
10. The University may vary the rules from time to time in a manner consistent with the University's legal obligations and policies.
11. The University reserves the right to withdraw the Prize if the Student Misconduct Tribunal has found the student guilty of misconduct and imposed a relevant penalty, including, but not limited to, having provided false or misleading information that has a relationship to the awarding of this Prize in accordance with the University's Policies, Rules and Statutes for Student Misconduct.
12. Once the Prize has been withdrawn for that year, it may be re-awarded to the next eligible student at the discretion of the School and subject to available funding.
