

Harvard referencing guide

The Harvard referencing style is commonly used in universities around the world. There are many different versions. The version used at the University of Adelaide is referred to as **Harvard UofA**. It is based on the *Style manual for authors, editors and printers* 2002, 6th ed., John Wiley & Sons, Milton, Qld.

This guide is a **guide only**. You may need to confirm specific referencing requirements for assignments with your lecturer or tutor.

Harvard is an author-date style.

When you refer to someone else's work, you need to include a reference to that work in two places:

- **In-text citation**: this is a short reference in your document, generally at the end of the relevant sentence or paragraph. It consists of the author's family name, the year of publication and the page number for direct quotes (and where possible for other citations) inside a pair of brackets.
- In the **reference list**: this is a complete list, in alphabetical order by author, of all the works you referenced in-text. The references give full details of each source.

Reference list

In your reference list, you usually include, in this order:

- Author's family name
- Author's initial(s)
- Year of publication
- Title of article or book, etc.
- Publication details (journal information, publisher information)
- Page numbers (if needed)

Here is a generic example for a journal article with three authors:

Author, AA, Author, B & Author, C Year, 'Article title in between single quotes, in lower case and with no full stop to end', *Journal Title in Italics with Capitals*, vol. ##, no. #, pp. ##-##.

In-text citations

In an **in-text citation**, provide the author's family name, followed by the year of publication. Enclose them in brackets at the end of your sentence. Include a page number where possible, especially if you are quoting directly from a source.

An in-text reference looks like this: It has been claimed that... (Author Year, p. #).

It could also look like this: Author claims that.... (Year, p. #).

Page numbers

Remember that **you need to include a page number if you quote or paraphrase**. To refer to a single page, use the abbreviation p. To refer to more than one page, use the abbreviation pp. For example, use (Jones 2010, p. 112) for referring to one page and use (Jones 2010, pp. 112-113) when referring to more than one page.

Journal articles

In print or from a UofA database

Author's family name, Initial(s) Year of publication, 'Title in single quotes', Journal Title in Italics, vol. ##, (volume number) no. #, (issue number) pp. #-# (page numbers the article covers).

You do NOT need to include a URL or database name.

From Web (freely available from an e-journal website)

Author's family name, Initial(s) Year of publication, 'Title in single quotes', *Journal Title in Italics*, vol. ##, (volume number) no. #, (issue number) viewed Date Month Year, pp. #-# (page numbers the article covers), <URL address>.

- If volume, issue, or page numbers are unavailable, you can leave them out.
- If there is other relevant information (e.g. publication month, article number), you can include that instead.

With DOI (Digital Object Identifier)

Author's family name, Initial(s) year of publication, 'Title in single quotes', *Journal Title in Italics*, vol. ##, (volume number) no. #(issue number) pp. #-# (page numbers the article covers), DOI:number.

- DOIs are not generally required for Harvard styles. However, if your lecturer requires them, add them at the end of the reference.
- If you include the DOI, you do not need the date viewed or the URL.

In press / advance online publication

Author's family name, Initial(s) year of publication, 'Title in single quotes', *Journal Title in Italics*, vol. ##, (volume number) no. #, (issue number) pp. #-# (page numbers the article covers), in press / advance online publication, DOI:number / viewed Date Month Year, <URL>.

- "In press" and "advance online publication" usually refer to articles that have been accepted for publication but not yet "officially" published.
- Give the journal information, then "in press" or "advance online publication".
- Follow with DOI if available/required, or date viewed, <URL>.
- If volume/issue/page number information isn't available, leave it out.

Two authors

Author's family name, Initial(s) & Author's family name, Initial(s) year of publication, 'Title in single quotes', *Journal Title in Italics*, vol. ##, (volume number) no. #, (issue number) pp. #-# (page numbers the article covers).

- Leave the authors' names in the order they appear on the article.
- Separate the authors' names with an ampersand (&).

Three authors

- Leave the authors' names in the order they appear on the article.
- Use an ampersand (&) to separate the last two authors.

- Leave the authors' names in the order they appear on the article.
- Use an ampersand (&) to separate the last two authors.
- In the reference list, include all authors.
- In the in-text citation, include first author then et al.

Books

In print

Author's family name, Initial(s) Year of publication, Title (in italics), Publisher, Place of Publication.

- If a book has many places of publication, choose the first.
- If a book has no place of publication, write n.p.
- Give any extra information needed to disambiguate (e.g. Cambridge, Mass. vs Cambridge, UK) or to clarify (St. Lucia, Qld, rather than just St. Lucia).

E-book (from UofA database)

Author's family name, Initial(s) Year of publication, Title (in italics), Publisher, Place of Publication.

- If no place of publication is available, only list the publisher.
- If a DOI is available, and your lecturer requires it, include this at the end of the reference.
- If page numbers are unavailable, you can leave them out.

E-book (from web)

Author's family name, Initial(s) year of publication, Title (in italics), Publisher, Place of Publication, DOI:number / viewed Date Month Year, <URL address>.

- If no place of publication is available, only list the publisher.
- Include date viewed and URL.
- If a DOI is available, you can give this instead of the date viewed and URL.
- If page numbers are unavailable, you can leave them out.

Two or three authors

Author's family name, Initial(s), Author's family name, Initial(s), & Author's family name, Initial(s) year of publication, Title (in italics), Publisher, Place of Publication.

- List all authors' names.
- Leave the authors' names in the order they appear on the title page.
- Separate the last two authors' names with an ampersand (&).

Four or more authors

- Leave the authors' names in the order they appear on the title page.
- Use an ampersand (&) to separate the last two authors.
- In the reference list, include all authors.
- In the in-text citation, include first author then et al.

- Give author and chapter information first, then editor(s), book title, and publication information.
- Include chapter page numbers at the end of the reference.
- For the in-text citation, give the chapter author and date.

• For the in-text citation, give the chapter author and date.

- If available, include a reference point (for example: figure number or table number) in the in-text reference for the dataset.
- The word figure can be abbreviated to fig.
- If there is no author name, use the authoring body (e.g. company or department) instead.

Webpage

Author's family name, Initial(s) OR Authoring body Year, Title of webpage (in italics), Title of website, viewed Date Month Year, <URL>.

- Where possible, reference the specific page or section (not the whole website).
- If there is no individual author name, use the authoring body name (company or organization see example below).
- If the website document doesn't have an individual OR corporate author, use the document title followed by the year.
- If there is no year, use n.d.

- If no full name is available, give the user name.
- If no date is available, use n.d.

- To reference an individual post within a whole blog, include the name of the whole blog and the date of the specific post.
- If no full name is available, give the user name.
- If no date is available, use n.d.
