<i>Terms of Reference:</i>	<p>To provide advice and make recommendations for Academic Board and the Vice-Chancellor's Executive on the University's internationalisation, including:</p> <ul style="list-style-type: none"><li>• Operationalising and monitoring the University's Connected to the Global World of Ideas Pillar, including related KPIs</li><li>• Increasing the number and diversity of International Students in line with strategic growth plans</li><li>• Increasing new international partnerships founded on research and teaching priorities</li><li>• Identifying and developing mechanisms to deliver international experience at home through the curriculum and other means</li><li>• The support and incentivisation of staff engagement with and awareness of internationalisation</li><li>• Identifying and developing opportunities to increase the proportion of students who study overseas</li><li>• Increasing engagement with our international alumni network</li><li>• Identifying the development or enhancement of systems and processes to support internationalisation</li><li>• The Terms of Reference are to be reviewed annually following engagement with each of the faculties coordinated through the DDIs</li></ul>
