
Collaborators from academia, government and the private sector work together closely on one-to-five-year projects.

By bringing together the expertise, capability, skills and high-tech facilities of research, government and industry partners, NHMRC Partnership Projects drive improved health services and policy for the benefit of all Australians.

Translating research into policy and practice

Projects with this goal can include, but are not limited to:

- studies of knowledge transfer and exchange mechanisms that will lead to improved Australian health outcomes through enhanced services
- research involving preventative programs, primary and community health care, hospitals, access to services, workforce, infrastructure and funding
- applying existing research-based evidence to develop more informed advice
- increasing health services' reach—and enhancing knowledge of how to implement them—through partnerships.

Identifying knowledge gaps

Projects with this goal can include, but are not limited to:

- identifying opportunities to improve health programs' and services' performance
- evaluating new approaches to improving service and program accessibility and untake
- monitoring and reviewing current policy and practice to gauge its impact and the need for change.

The NHMRC encourages projects that investigate the impact on health outcomes of services' systemic features (e.g. funding, planning, organisation, regulation and performance management). It also often includes specific priority health objectives for Partnership Grants in any given round. Funding allocations

The NHMRC funds its Partnership Projects from an estimated pool of over \$30m, with budget requests limited to \$1.5m.

Partner contributions

Partner Organisations (combined) must contribute at least 50% of the total value of the research project in cash and/or in kind. The level of funding requested from the NHMRC must not exceed the total contribution from the Partner Organisations.



Partner eligibility

Partnership Project applications must be jointly submitted by an Administering Institution (generally an Australian university) and one or more Partner Organisations.

Partner Organisations must have the capacity to improve Australians' health, and/or our country's health policy and health care delivery. Each Partner Organisation must demonstrate in the application how their project involvement will contribute to this outcome.

Organisations that are capable of implementing policy and service delivery but would normally *not* be able to access funding through most other NHMRC mechanisms, are highly valued as partners.

This includes:

- federal, state, territory or local government organisations in the health portfolio, and other areas affecting health, such as economic policy, urban planning, education and transport
- private-sector healthcare providers, private health insurance companies and private hospitals
- non-government organisations and charities
- community organisations, such as consumer groups
- professional groups.

Overseas organisations can also participate, so long as it can be demonstrated that their involvement will bring clear health policy and/or service benefits for Australians.


