

COMPETITION TERMS AND CONDITIONS

1. The name of the Competition is “Win a Double Pass Showdown Experience in The Bunker.”
2. The Competition is being run by Adelaide University (ABN: 41 202 953 738 and CRICOS Number: 04249J) in Adelaide, South Australia, 5005, telephone +61 08 7420 5115.
3. The Competition commences at 9:00 AM ACST on Monday 7 July 2025 and closes at 11:59 PM ACST on Tuesday 15 July 2025 (“Competition Period”).
4. Information on how to enter the Competition and about prizes forms part of the Terms and Conditions. Participation in the Competition is deemed to be acceptance of these Terms and Conditions.

Entry

5. Entry is open to any current member of staff of either Adelaide University, University of Adelaide or University of South Australia aged 18 years or over at the time of entry.
6. The entry form is available at <https://forms.office.com/r/bQvuyAayKQ> (“Entry Form”).
7. Eligible entrants may enter the Competition during the Competition Period by submitting a completed Entry Form which includes:
 - a. a response of 300 characters or less to the question “You have 30 seconds to convince a colleague to support the Crows — what do you say?” (“Question”); and
 - b. the entrant’s first and last name and university email address.
8. Only one entry per person is permitted for the Competition.
9. Adelaide University personnel directly involved in the administration or judging of this competition are not eligible to enter the Competition.
10. Entries must be the entrant’s original work. Adelaide University reserves the right to verify, or to require the entrant to verify, that the entry is original, and to deem entries that cannot be confirmed as original to Adelaide University’s satisfaction as invalid.
11. By entering the Competition, entrants agree that they are the owner of all intellectual property in the entry being submitted, and have the necessary permissions to submit it for the purposes of the Competition.

Prizes

12. Adelaide University is giving away 3 prizes, each valued at \$880. Each prize comprises 1 double pass (i.e. 2 tickets) to The Bunker at Adelaide Oval for the Australian Football League Round 20 Adelaide Crows v Port Adelaide Showdown game on Saturday 26 July 2025. There will be 3 winners with 1 prize to be awarded to each winner.

13. Winners will be selected on Wednesday 16 July 2025 by a judging panel comprising members of Adelaide University's Sponsorship Team (or delegates). The judges will select winners on the basis of their determination of the most creative answer to the Question.
14. The judges' decision is final and no correspondence will be entered into.
15. Winners will be notified from Thursday 17 July 2025 via email from Jacoba.clough@adelaide.edu.au.
16. Prizes will only be awarded following validation and verification of winners and their entry.
17. Adelaide University reserves the right to verify winner eligibility and request proof of identity and/or age and proof of entry validity to claim a prize. Proof considered suitable for verification is at the discretion of Adelaide University and if the winner cannot provide suitable proof, the winner will forfeit the prize in its entirety and no substitute will be offered.
18. If Adelaide University is unable to contact a winner or validate or verify an entry within 7 days of the judge's decision or if a winner is unable to receive the prize, the prize will be forfeited in its entirety and no substitute will be offered, and that prize will be offered to a runner-up, or Adelaide University may dispose of or otherwise deal with that prize as Adelaide University sees fit.
19. Prizes are not transferable or redeemable for cash and have an expiry of Saturday 26 July 2025. No responsibility is accepted for any variation in the value of the prize pool.
20. Adelaide University is not responsible for any additional costs associated with entering or winning the Competition or any of the prizes.
21. Fulfilment of the prizes is subject to the terms and conditions of the third-party supplier of the prizes and is subject to availability.
22. Prizes will be emailed to winners by Friday 25 July 2025 from afconline@afc.com.au (unless Adelaide University agrees to an alternative arrangement for delivering a prize to a winner).

Miscellaneous

23. If there is any inconsistency between these Terms and Conditions and anything else that refers to the Competition, these Terms and Conditions will prevail.

Adelaide University reserves the right to disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these Terms and Conditions, or who has, in the opinion of Adelaide University, engaged in conduct in entering the Competition which is fraudulent, misleading, deceptive, or generally damaging to the goodwill or reputation of Adelaide University or the Competition. This includes, but is not limited to, entrants using multiple email addresses or identities to submit multiple entries, entries which are breaches of copyright, and entrants who submit outside the Competition Period.
