The University of Adelaide Student Services and Amenities Fee (SSAF) 2024 Allocation Report

Introduction

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 (SSARA Guidelines) require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

The information provided in this SSAF Allocation Report does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting is a separate process and remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP (FVI)</u> for all other approved providers.

SSAF Consultation and Achievements

In allocating the SSAF for 2024, the University has undertaken a two-phase consultation process with students. The first phase involved surveying all students regarding their priorities for allocation of the SSAF.

The second phase involved consultation with democratically elected student representatives as required under the Student Services, Amenities, Representation and Advocacy Guidelines. This consultation was carried out through the SSAF Consultative Committee, which was established in 2011. This committee comprised student representatives from the YouX, Student Representative Council, international and postgraduate student representatives as well as Adelaide University Sport and Fitness (AUSF).

YouX, AUSF and the University were asked to submit SSAF funding requests on behalf of all groups to the committee. They were asked to take feedback from the student survey into account when forming these submissions. The Committee then made recommendations to the University on the allocation of SSAF funding for 2024. In line with Section 19-39(3) of the Act more than 40 per cent of SSAF revenue collected was provided to the student-led organisations YouX and AU Sport.

A snapshot of successful 2024 SSAF funded activities include:

- Over 565 casual job vacancies promoted via the YouX Jobs Board.

- o Facilitation of an administrative and governance framework for 169 Clubs enabling them to function and thrive autonomously.
- Management of a \$179,000 grants program to promote a dynamic, collaborative, and inclusive student experience, including delivery of over 390 individual grants in 2024
- Delivery of annual training and development programs and event support and advice.
- Events that enable social, wellbeing and educational activities for all students:
 - Delivery of a year-round program of free and accessible events to encourage campus community. 2024 saw the delivery of over 70 events across the University's campuses, servicing approximately 22,000 students.
 - Provision of comprehensive and welcoming orientation event programs across all campuses to help students start University successfully
 - o Delivery of dedicated wellbeing, stress relief and exam support events and activities

The term "part-time basis" means a study load of less than 75 per cent of the normal full-time student load for the period to which the fee relates. As per part 7 of the Administration Guidelines, the normal EFTSL value for a full-time student studying over a period of one year is 1.0.

³ Note: Students are categorised as full-time or part-time students based on the total EFTSL value of the units of study they undertook in [insert reported year].
