



South Australian Entrepreneur Awards 2022 Terms and Conditions

By nominating to enter in the 2022 South Australian Entrepreneur Awards, each nominee agrees to be bound by the following Terms and Conditions (as amended from time to time).

1. Background

1.1. The South Australian Entrepreneur

Awards an initiative of the University of Adelaide's ThincLab in partnership with the Entrepreneurs' Organization (EO).

1.2. Organisers

The Organisers are ThincLab, and EO or their agents, and are responsible for the general management of the **South Australian Entrepreneur Awards**.

1.3. Judges

The Judges are individuals selected by the Organisers to be members of the panel that are responsible for assessing the nominees applications.

1.4. Key Dates

Nominations for the awards open on Friday 11 March 2022 and will close at midnight on 21 May 2022. Finalists will be notified by 1 June 2022 and winners announced on 25 June 2022.

2. Entry and Eligibility

2.1. Mode of Entry

To nominate for the South Australian Entrepreneur Awards, each entrant must complete the nomination form

2.2. Eligibility

- 2.2.1. Entry is open to all residents of South Australia only
- 2.2.2. The following persons are not eligible as Competitors:
 - 2.2.2.1. Staff or officers of the Organisers or partners or family of such persons;
 - 2.2.2.2. Judges.

2.3. **Entry**

2.3.1. Nominees must only enter the one category (Emerging);

2.4. Correspondence

Any correspondence from the Organisers to an entrant will be directed by email, or other such means as the Organisers choose.

3. Prizes and Decisions

3.1. Prizes

Prizes will be awarded as defined on the website:

https://www.adelaide.edu.au/thinclab/partnerships/south-australian-entrepreneur-awards. Some prizes may be subject to eligibility conditions. The Organisers may, at their discretion, award additional prizes to any others. The Organisers may, at any time, and without notification to any person, vary any of the prizes, providing that the value of the prizes is equal to those listed on the Prizes page. If a prize is no longer able to be awarded due to circumstances beyond the Organisers' control, the Organisers may decide not to award a replacement prize.

3.2. Non-transferability of Prizes

By entering the Competition, Competitors acknowledge and accept that prizes are not redeemable for cash and are not transferable.

3.3. **Deferring of Prizes**

Prizes must be claimed and used within twelve (12) months of issue. If the winner is unable to use the prizes, the Organisers retain the right to renegotiate the terms of use; reissue or cancel the prizes.

3.4. Date and notification of decision

The names of the winners to receive a prize will be announced at the EO Annual Dinner on Saturday the 25th June 2022.

3.5. Finality of decision

The decisions of the Judges will be final. No communication will be entered into with any person in relation to any decision of the Judges.

4. Use of your details

4.1. Privacy

- 4.1.1. The Organisers will use the details you provide at nomination to:
 - 4.1.1.1. communicate awards related notifications;
 - 4.1.1.2. add you to the Organiser's mailing list for newsletters and future related opportunities;
 - 4.1.1.3. Undertake statistical analysis for the Organiser's internal purposes.
- 4.1.2. Your personal information will be stored in accordance with the University of Adelaide's Privacy Policy (www.adelaide.edu.au/policies/62). Please refer to this Privacy Policy for

4.2. Consent to photographs / video / audio footage

- 4.2.1. All the entrants will be deemed to grant permission to the Organisers and its agents, to use, reproduce and communicate photographs, video and audio footage taken of members of the team for use in South Australian Entrepreneur Awards related press and marketing materials, including but not limited to: social media, media releases, advertising, etc.
- 4.2.2. Award winners will make themselves available for interviews and other marketing activities upon reasonable request.

5. No liability

- 5.1. None of the Organisers, Judges, or any employee or agent of the Sponsors will be liable to any entrant for:
 - 5.1.1. Any costs incurred or loss or liability suffered by Competitors or Teams in relation to the South Australian Entrepreneur Award;
 - 5.1.2. Any other benefit that entrants expect to gain by participating in the South Australian Entrepreneur Award.

6. Cancellation due to Force Majeure

- 6.1. If the Event is cancelled due to Force Majeure Event, the Organisers retain the right to:
 - 6.1.1. Cancel the event without liability or loss to the Applicants caused by the cancellation;
 - 6.1.2. Postpone or reschedule the Competition and Judging timeline.

7.1. Change of Terms and Conditions

The Organisers may change these Terms and Conditions any time, without specific notice to you.
